## The Chitrapur Saraswat Education and Relief - Appeal

The Chitrapur Saraswat Education and Relief Society, Santacruz (CSERS) was constituted in the year 1946 with a primary objective of helping needy and deserving students and giving a helping hand to the aged, sick, invalid people in the areas of medical treatment or distress relief.

CSERS is registered with Bombay Public Trusts and managed by a Managing Committee of eight members all working on an honorary basis.

CSERS is one of six similar institutions in the city of Mumbai. A Coordination Committee formed by these six independent Institutions jointly scrutinizes the applications received from recipients and ensures that there is a uniform distribution of Aid thereby discouraging the tendency of same recipient trying to get the aid from more than one institution simultaneously. Contributions from CSERS during the last 5 years are in excess of 50% of Aid given by all the institutions together.
